Procedure for admission (ON-LINE applicants):

- Parent(s) (or Legal guardians) along with the child shall compulsorily report to the Vidyalaya as per the schedule notified to the venue along with the copy of the e-mail by OLA KVS-MGRM.
- Show the downloaded copy of seat confirmation mail, acknowledgement slip and inform the QUOTA, Serial No. in the list. On tallying the number and name, a token slip will be provided to you.
- As per the token number, the parent would be required to complete document verification. Please bring the following documents for this purpose.
 - A print out of the online application on A4 papers
 - Affix a passport size photograph of the child on the top right corner.
 - Append a set of the following documents **in the same order**.

- d) On the successful verification of credentials from the documents submitted, with the ONLINE DATA furnished by the applicant, an admission form will be provided.
- e) Parent(s) has to fill the form carefully and legibly and sign in the space provided. Submit the completed form to the concerned official and wait for receiving the online challan for payment in the UBI portal. This may take time, hence, one representative may have to wait for a minimum of 15-30 minutes, in the area earmarked.
- f) The challan amount has to be remitted in the UBI and a copy of the same shall be returned to the admission team. Admissions of RTE /Other exemption cases will have to ensure challan generation and might have no physical payment of fee, which has to be ascertained.

Note:

- i) Children of Govt. Employees (i.e., CAT I, II, III and IV) selected under RTE quota shall also have to pay the fees as per KVS prescribed rates.
- ii) Children of parents under category 5 (private) select under RTE quota, are totally exempted from payment of fee, on production of valid documents, and other criteria as laid by the KVS.

Please Note: Any mismatch of information to any extent would lead to disqualification & rejection of admission .In case of any short fall of documental requirements, parent/ guardian has to submit the same in a definite time frame to complete the admission. Non submission of the short fall of documents in stipulated time frame would lead to cancellation of seat.

The set of documents submitted by the candidates who reports for verification shall not be returned whether they are admitted/rejected/pending.

Present fee structure: Quarter wise as per the KVS norms to be paid by challan in online or offline mode.
